How to participate

It is required that you enter the e-mail address you provided when registering for the general meeting.

Note:

You can only access the form if you in advance of the General Meeting have registered your VP deposit number or registered personal bank account number and by name registered in the company's shareholder register.

How to ask questions

It is important that you have muted your microphone during the general meeting.

If you have a question or a comment, then you can either mark with a show of hands or write on the chat function.

How to "Raise Hand"

Click on the handshake icon "Raise hand".



When the chairman leaves the word to you, you activate your microphone and ask the question and/or comment you have.



Subsequently, you mute the sound again.

You are welcome to write in the chat function, then the conductor will answer your question or read your comment aloud.
